In our desire to remove any barrier to survivors accessing our services, we undertook the task of changing our name.

We believe that the name *Roanoke Park Counseling* is reflective of our treasured location and our deep and grounded connection to the community.

Only our name and logo have changed. Our services to survivors remain exactly as they have been. We are deeply connected to the long and rich history that has allowed us to provide such rare and dependable therapy to adult survivors over the years and we are sincerely committed to continue our strong and steady mission to provide the highest quality services to survivors as we move forward.



### A Message from the Executive Director

We are in a time of unprecedented fear and changes to the life we have lived day to day as we deal with the coronavirus pandemic. In the face of so much unknown it can be difficult to find a way to maintain any kind of steady balance. **First and foremost, I hope that you and your loved ones are safe and healthy and finding a way to stay connected while maintaining a necessary but difficult distance.**

In this time that seems so unknown and uncertain, we hear from survivors that, although they are dealing with the struggles of this global pandemic as we all are, there is something sadly familiar about the insecurity and uncertainty of this time. As Cecily\* explained, "I'm coming to realize that there is a way that I know this time already – I know what it's like to live with constant fear and uncertainty.

For the 10 years my uncle was living with us, each day I woke up wondering if today was a day I would be abused. For every day of those 10 years I never ever knew when I was safe. That is a time I don't ever want to remember, but it's like now it's here with me every day."

As we all struggle to live with the challenges that this new reality has brought to our lives, we understand that for survivors and their families, the effect of these challenges is even more complex and impactful. We have made every effort to be able to provide safe and consistent therapy to survivors during this time by offering telehealth sessions. We hear the palpable relief from survivors who find that our staff is ready and able to continue to provide the human

As many will face job loss and subsequent loss of medical benefits, we are anticipating that the need for scholarship support may be greater than ever before.

## Hope in Healing Spring Scholarship Fund

May 1-15, 2020

The Hope In Healing Scholarship Fund is an online fundraiser intended to provide support for survivors who need the most financial help to find healing through our specialized counseling services.



In 2019, 13 clients received scholarships totaling \$18,632.50. We expect the need to be significantly greater this year due to the economic uncertainty ahead.

### Your gift will make healing possible!

- Your gift of \$50 will allow a survivor to begin group therapy.
- Your gift of \$100 will allow a survivor to begin their path to healing through individual therapy using our sliding scale.
